This is a comment on the proposed regulation of retail forex, RIN 30-38-AC61, whereby the maximum leverage allowed would be reduced to 10 to 1. The current leverage used is 100 to 1 and it allows retail forex traders to make a living with this leverage. If the maximum leverage is changed to 10 to 1 it will eliminate the ability of the average retail forex trader to make a living. In the current economic conditions I do not think it is wise to eliminate additional means of making a living for people in the United States. If such legislation is passed the more advanced traders will be forced to look outside the United States to continue trading.
